SB Digester – Organic is a liquid product used in breaking down crop residue. This product is a soil amendment that is a combination of living, beneficial microorganisms that have the ability to degrade a wide variety of organic polymers such as starch, cellulose, chitin and lignin. Can be applied alone or in combination with other conventional or organic post-harvest products. Physical compatibility test is recommended. Agitate or mix prior to applying or blending. To prevent damage to microbes, keep out of direct sunlight. Store in a cool place. Replace cap to container immediately after use.

RECOMMENDED APPLICATION RATE

Broadcast spray at a rate of 1 to 2 gallons per acre. For agronomic application rates suitable for your crop, geographic area and soil type, consult a trained specialist and apply as needed based on a soil test, tissue analysis and/or according to recommendations in your SoilBiotics Crop Management Plan.
